

Following the release on its SUV result, ASEAN NCAP made another assessment on a Nissan's model, Nissan Navara, its popular pickup truck. In Adult Occupant Protection (AOP) category, Nissan Navara had reached a 4-Star rating at 12.34 points. As for Child Occupant Protection (COP), Navara scored 2-Star rating with 37% compliance. Anti-lock Braking System (ABS), Electronic Stability Control (ESC) and Seatbelt Reminder (SBR) are offered as optional package. The model uses seatbelts as attachment method for child restraint system.
